NOTICE OF AMENDED APPLICATION IN COMPLIANCE WITH RULE 3.2(B)

On May 8, 2007, Southern California Edison Company ("SCE") filed Application No. 07-05-003 with the California Public Utilities Commission ("CPUC") requesting an authorized cost of capital for 2008. On May 11, 2008, SCE notified certain parties of this application.

It has come to SCE's attention that that application, designated A.07-05-003 by the CPUC, contained a table with an incorrect reference to dollar amounts in the table entitled "Projected Customer Group Revenue Impact Due to Requested Change in the Cost of Capital – 2008." Specifically, the error was located in the column labeled "Revenue Change (\$ Millions)." Rather than set out the revenue change in millions, the column should have been labeled "Revenue Change (\$ Thousands)."

Accordingly, on May 15, 2007, SCE amended its application. The amended application changed the referenced table to read as follows:

*Projected Customer Group Revenue Impact
Due to Requested Change in the Cost of Capital – 2008*


Customer Group	Revenue Change (\$ Thousands)	%
Domestic (Residential)	8,166	0.18%
Lighting – Small & Medium Power	5,757	0.13%
Large Power	2,433	0.10%
Agricultural & Pumping	525	0.16%
Street and Area Lighting	20	0.02%
Total	16,902	0.15%

The amendment to the application was necessary because, as the table was originally set out, it is possible to misconstrue SCE's application to be a request for more than \$16.902 million in 2008, which it is not. Accordingly, SCE has filed an amended application to clarify any potential confusion.¹

¹ Except for the noted error, SCE incorporated the application it filed on May 8, 2007 into the amended application.


