to Path 49.” (June 9, 2006 Transmittal Letter at p. 2.) The filing requested a July 1, 2006 effective date for the Amended MATA.

On July 3, 2006, SDG&E filed an intervention and a motion for clarification in this proceeding. On July 5, 2006, IID filed a motion to intervene. Neither SDG&E nor IID opposed the Amended MATA or the proposed effective date of July 1, 2006 for the Amended MATA in their respective interventions.

Rather, it appears that SDG&E and IID have a dispute – for the resolution of which SDG&E sought Commission guidance in its motion for clarification – concerning an agreement (“MOU”) between IID and SDG&E, and more specifically about the need to file this MOU with the Commission. The MOU dispute, however, does not and should not have any bearing on the approval of the Amended MATA, or the requested effective date of July 1, 2006. (Indeed, IID has taken the position in its filing that the “subject matter” of the MOU is “irrelevant” to this Amended MATA proceeding. *See* IID Motion to Intervene at p. 3.)

SCE is filing this response to assure that any disputes concerning MOU do not delay the approval of the Amended MATA which has been filed on behalf of all of the Parties, and which is not opposed by any party to this proceeding. SCE, therefore, requests that the Commission expeditiously approve the Amended MATA with an effective date of July 1, 2006.

II. CONCLUSION

For all of the foregoing reasons, SCE respectfully requests that the Commission expeditiously approve the Amended MATA with the effective date of July 1, 2006.
