**BRIEF DESCRIPTION OF COMMUNICATION:** Mr. Backstrom spoke as a panelist as part of the EPRI Electrification 2018 Conference. Commissioner Peterman was a panelist on the same panel. During his comments, Mr. Backstrom stated that transportation electrification (“TE”) is imperative to reach California’s greenhouse gas-reduction goals. Mr. Backstrom also mentioned SCE’s Clean Power and Electrification Pathway, which calls for seven million

electric vehicles by 2030 meet those goals. He described the importance of sending a clear signal about the durability of TE-related programs. Mr. Backstrom also mentioned the importance of workplace charging availability and incentivizing charging through time-differentiated rates that correspond to grid conditions when renewable energy supply is abundant.
