Pursuant to Rule 12.1(b) of the Rules of Practice and Procedure of the California Public Utilities Commission (Commission), Southern California Edison Company (SCE) hereby serves notice that it will host an all-party settlement conference to discuss resolution of its Application for Approval of Its Charge Ready and Market Education Programs (A.14-10-014).

SCE notes that the settlement conference will be held subject to Article 12 of the Commission's Rules of Practice and Procedure and is therefore limited to parties and their representatives only.
